The Government of the Republic of Kenya has received Financing from the African Development Bank in various currencies towards the cost of Kenya Towns Sustainable Water Supply and Sanitation Programme. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for **Water Distribution Works for Malindi Water and Sewerage Company (MAWASCO)-WATAMU LOT 2A in Coast Water Works Development Agency Area.**
